MINUTES WEAVERVILLE FIRE PROTECTION DISTRICT

Regular Meeting - January 2, 2018

- I. CALL TO ORDER: The Regular Meeting of the Weaverville Fire Protection District was called to order by Chairman, Larry Helsley at 1001 hours. Commissioners present: Bill Britton, Bill Fischer and George Owen. Others present: Fire Chief Todd Corbett, Engineer Larry Horrocks, and Administrative Officer Serena Brown. Those absent: Commissioner Rick Wetzel

- a. Discussion/Approve Yearly Ethics Board Member Training Administrative Officer Brown reminded the commissioners that it is time for the yearly Ethics training. California Special Districts Association offers a webinar free for members. It was decided that all Commissioner will watch the webinar together on Monday, January 22, 2018 at 10a.
- b. **Discussion/Approve Resolution 18-1, Regarding Worker's Compensation** SDRMA needs a resolution that states we, as a District, cover all volunteers with Worker's Compensation Benefits. Resolution is attached.

- c. Discussion/Approve Increase Budget for Firefighter Pay The Board was presented with a verbal report regarding the balance of the Firefighter Fund. There are currently insufficient funds to cover the pay of all the firefighters who responded to the Thomas Incident. It's the wish of Fire Chief Corbett that all firefighters be paid for their time spent on the fire. Administrative Officer Brown recommended that \$20,000 be 'borrowed' from the investment account and added to the Firefighter Fund. The monies will be 'repaid' to the investment account upon receiving payment of the incident. It is unknown when the Fire Incident Income will be available.

- d. Discussion/Approve Purchasing a Water Tender and procedures for opening the bidding process. Chief Corbett presented the board with a verbal report on his research of water tenders. He has three potential vendors that meet the requirements we are looking for. Britton has a template for writing up specs that was used during the purchase of 2111. A committee will be assigned.
 MSC Britton/Owens approve for the future use of a water tender and a committee of Chief Corbett, Commissioner Britton, and Captain Alvord was set to start building specs.
